This vaccination is recommended to help protect your child against influenza (flu). Flu can be an unpleasant illness and can cause serious complications. Vaccinating your child will also help to protect more vulnerable family and friends by preventing the spread of flu.

In order for your child to receive this vaccination when we visit your school on **Tuesday 23rd September 2025**, please complete the e-consent form by **Wednesday 17th September 2025**.

- Please visit www.surreyimmunisations.co.uk and enter your school's unique code **SR125067**
- If you **do not** want your child to receive a vaccine, we would ask you to still complete a consent form but select the 'No' option.
- If you do not want your child to receive the nasal spray vaccine on the basis of its porcine gelatine content, please fill in the 'No' box indicating this, and you will be given the opportunity to consent for an alternative vaccination. This vaccination is delivered by injection into the arm and does not contain any porcine gelatine. We will deliver this in school when we visit. If, however, you would like your child to receive this vaccination in one of our clinics, please contact us on the above number or email.
